## What you can expect from us

As a client of The Equality & Human Rights Commission, you have the following rights regarding the confidentiality of your personal information and communications with The Equality & Human Rights Commission Commissioners and staff.

1. The information that you provide to us will be kept confidential to the fullest extent allowed by law.
2. You may choose what information you want to provide to The Equality & Human Rights Commission. You will not be denied access to services if you choose to not provide certain information.
3. The information that you provide to us, including your name, address, phone number, and other personal information will not be shared with anyone outside the Commission without your permission.
4. The Equality & Human Rights Commission staff may be required by law to report certain situations even if you don't give them permission to share or report the situations. For example, we have an obligation to report suspected child abuse or neglect, threats to self or others, elder or vulnerable adult abuse or the planning of a crime. If a crime is disclosed to us we will seek advice from the Attorney General and may have to report it. Commissioners and Staff will inform you of any reporting requirements prior to having conversations with you and will tell you when they must make a report and what information will be shared. Even when these reports are made, The Equality & Human Rights Commission will not share information beyond what is required by law.
